Definition of Purpose, Data Categories and Data Subject

Purpose Name	Description
Business Operation / Value-Adding	Covers all activities of the customer lifecycle, i.e. marketing, order placement, delivering ordered services as well as billing and payment.
Marketing	Planning and execution of activities to generate sales leads (acquisition) as well as to identify potential opportunities from existing customers (development). Planning includes the development of Sales Plans, Customer Development Plans and Lead Generation. Leads are then generated from various sources, including campaigns targeted at different channels.
Contracting	Qualifying a prospective customer (new or existing) based on a Lead, providing them with accurate offers and establishing a contract or agreement with them. It includes capturing customer Information, screening the customer and eventually a post-implementation review of the implemented agreement.
Sales	Ordering and booking services, and the subsequent billing and payment associated with the original order for the service.
Service Delivery / Contract Performance	It contains all activities undertaken to deliver the products and services ordered by the customer.
Procurement	Contains all the steps from purchase of goods and services to payment of third-party vendors who provide goods and services to DHL. These goods and services include aircraft fuel, packaging supplies, software licenses, contracted service partners or professional services.
Customer Service	Handling of a case that is raised as the result of a query needing investigation, or an incident, complaint or some other situation which requires investigation and further action for it to be resolved.
Human Resources	Covers every part of the employee lifecycle, from being hired to retirement and beyond. It includes recruitment, employee onboarding, support of development and all administration including payroll and performance.
Recruitment	Processing data of job applicants for selection and hiring processes. This may include CVs, application forms, interview notes, and references.
General Administration	Processing data for general employment-related activities such as managing employee records.
Payroll and Benefits	Processing data to manage payroll and providing benefits. Includes reimbursement of expenses e.g. for travel.
Training and Development	Processing data to manage and track employee training, certifications, professional development activities, and career progression.
Attendance and Performance	Processing data to plan and manage work schedules, vacation, sick leave, maternity/paternity leave, and other forms of absence, evaluating and conducting performance reviews.
Health and Safety	Processing data to ensure a safe and healthy work environment, including the management of occupational health and safety records, accident reports, and risk assessments.
Communication and Events	Processing data to facilitate internal communication, distribute company news, and organize corporate events.
Disciplinary and Grievance	Processing data in relation to employee disputes, complaints, investigations, disciplinary actions, and legal proceedings.
Equality and Diversity	Processing data to monitor and promote equal opportunities and diversity in the workplace.
Termination	Processing data related to resignations, retirements, redundancies, dismissals, and exit interviews.
Post-Employment	Processing data for the provision of references, managing pensions, and maintaining alumni relations.
Business Support	Covers all activities that support business operation and running an enterprise. It includes providing technology, infrastructure, security, legal and financial services.
IT-Management	This includes IT operations, system administration, network management, and troubleshooting.
Product Development and Improvement	This includes research and development, quality assurance, and product improvement.
Security and Fraud Prevention	This involves secure business operations, preventing fraud, and ensuring network and information security.
Risk Management	Processing data to assess and manage business risks, excluding security and fraud.
Governance and Compliance	Processing data for internal audits, business management, strategic planning, and complying with legal obligations.
Finance	This includes finance operations, ESG, controlling, tax, investor relations, financial audit.

Data Subject Category Name	Description
Employees	Includes personal data of existing employees, trainees, interns or volunteers as well as potential future employees i.e. job applicants. Temporary staff and contractors employed via an external agency but treated equally to DHL employees are considered employees.
Customers	Includes personal data of interested parties /prospects as well as existing customers or customers of DHL Group customers (e.g. eCommerce shippers). Shipment shippers and consignees/receivers including alternative delivery recipients (e.g. neighbor, reception staff) are considered customers.
Others	Includes personal data of vendors/suppliers, visitors, emergency contacts or complainants.

Data Category Name	Description
Algorithmic and Profile Data	Any automated processing of personal data used to evaluate or predict personal aspects related to an individual, such as work performance, economic status, health, preferences, interests, reliability, behavior, location, or relocation. This includes rating portals, collection services, and claim assignments.
Audio-visual Data	Data collected for systematic and extensive monitoring, including recorded audio-visual footage (e.g., CCTV, screen recording, recording of online meetings incl. transcription) and environmental analysis using video-based sensors in automated or autonomous driving, subject to algorithmic processing.
Business Contact Information	Data used for order processing, contract performance, customer communication, and service hotlines. Examples include first and last names, addresses, telephone/fax numbers, email addresses, job titles/descriptions, dates of birth, contract information, complaint management, customer contacts, order data, invoicing data, and billing cycles.
Civil Servant Data	All data related to a civil servant directly connected to their employment, such as remuneration grades, length of service, anniversary dates, and disciplinary proceedings.
Criminal Record Data	Data on criminal convictions, offenses, and related suspicions, including precautionary measures (e.g., exemptions from criminal liability). Note: Misdemeanors are not included. Importantly, only the offender's data is considered, not that of accidental participants such as witnesses.
Employment Administration Data	Data primarily used in HR systems for employee master data or business directory information, including first and last names, business addresses, business telephone/fax numbers, business email addresses, home email addresses, home telephone/fax numbers, other employee data (e.g., home address, date of birth, communication data), employee ID/Group Universal ID (GUID), employment status (e.g., entry/exit date, permanent/temporary employment, trainee), marital status, and job titles/descriptions.
Identification Data	Information that uniquely identifies an individual, such as identification document types (ID card, passport, driver's license), document data (last name, first name, document number, nationality, registered address, date of birth, expiry date, issuing authority, date of issue), and account numbers and access codes.
Legally Limited Capables and Minors	Explicit documentation of legal capability or market offers specifically targeting this group, such as websites designed for minors that allow account creation/registration.
Location Data	Data from geo-tracking or other tracking devices on vehicles, physical assets, or shipments, as well as employee ID badges for access control systems.
Payment and Financial Data	Data used for payment processes and contract performance, including account numbers/IBAN, bank codes/sort codes/BIC, financial institution names, credit card numbers, expiration dates, and CVV codes.
Personal Characteristics & Behaviour	Data used for monitoring user behavior, such as cookies, Google Analytics, and other profiling or other behavioral analysis tools.
Personal Contact Information	Contact information including first and last names, business addresses, business telephone/fax numbers, business email addresses, home email addresses, home telephone/fax numbers, home addresses, dates of birth, communication data, employee IDs/Group Universal IDs (GUID), employment status (e.g., entry/exit date, permanent/temporary employment, trainee), marital status, and job titles/descriptions.
Professional Secrecy	Data is held under professional secrecy, such as patient files, medical reports, and diagnostic data by company doctors or medical services. Note: This does not include postal secrecy.
Sensoric Data	Data collected from sensors or signals from third-party mobile devices or interfaces of third-party personal electronic devices, such as processing of radio signals (WiFi, Bluetooth, or mobile phone) from employees, customers, or passers-by for location or behavior determination, motion profiles, and traffic flow analysis. Comprehensive data allows evaluation of driving behavior (e.g., analyzing braking and acceleration to optimize fuel consumption).

Special Categories	Information about racial or ethnic origin, political opinions, religion or philosophical beliefs, trade union membership, genetic data, biometric data, sexual orientation, and health. This includes medical diagnoses, disabilities, information on medical treatments, and the number of sick days, including data from sensors like fitness bracelets or new technologies such as telemedicine.
Telecommunication Data	Telecommunication Data: Data related to telecommunication services, such email, chat or instant messenger data, and audio recordings in call centers without algorithmic analysis.
User Identifier and Authentication	Data used for user authentication and access control, including user IDs, login data (start/end date and time), names, and passwords, codes or PINs.
