- \*T-1:** The Finnish customs office demands a caution for transit goods under T1 document. This caution has to be deposited by the company responsible for the establishment of the T1 document. As a consequence, these shipments will be subject to additional surcharges. These surcharges are not applicable for shipments to be delivered in the third country of destination by one of the partners of the Deutsche Post Group
