<p>The commodity description shall contain the product material and usage, and at least, the description should be recognized by people to know what it is.</p> <p>For example :</p> <p>Description includes material, usage, and category</p> <ul style="list-style-type: none"> • Material: metal, plastic, paper, cotton • Usage: medical use, common use, military use • Category: toy, bag, book, jacket, mug, tea cup <p>Highlights:</p> <ol style="list-style-type: none"> 1) 食品（含食品相关产品） Food (Including food related products) 2) 饮料 Beverages 3) 营养品（如维他命等） Supplements (e.g. vitamins) 4) 药品 Pharmaceuticals/Medical Materials/Drugs and other controlled substances/Radiological devices 5) 酒 Alcohol 6) 烟草 Tobacco 7) 动植物标本 Animal and Plant Specimens 8) 杀虫剂 Insecticide 9) 除草剂 Herbicide 10) 其他加拿大禁止进口产品（如管制刀具、弓箭等） Other prohibited products: weapons, firearms <p>Liquids and powders are also unacceptable.</p>
