**Canada Import Prohibited Goods**

Certain goods are not allowed to be imported into Canada. This includes the obvious such as child pornography and hate propaganda, as well as less obvious items such as used mattresses and some used automobiles.

In the course of administering the many laws of Parliament that regulate, control or prohibit the importation of goods into Canada, CBSA officials deal with a wide range of goods.

- Obscene Material  
Goods are deemed to be obscene under the Criminal Code if the materials exhibit, as a dominant characteristic, the undue exploitation of sex, or of sex and any one or more of the following subjects, namely, crime, horror, cruelty, and violence.
- Coin, Base or Counterfeit
  - a. a false coin or false paper money that resembles or is apparently intended to resemble or pass for a current coin or current paper money,
  - b. a forged bank-note or forged blank bank-note, whether complete or incomplete,
  - c. a genuine coin or genuine paper money that is prepared or altered to resemble or pass for a current coin or current paper money of a higher denomination,
  - d. a current coin from which the milling is removed by filing or cutting the edges and on which new

- milling is made to restore its appearance,
- e. a coin cased with gold, silver or nickel, as the case may be, that is intended to resemble or pass for a current gold, silver or nickel coin, and
  - f. a coin or a piece of metal or mixed metals that is washed or coloured by any means with a wash or material capable of producing the appearance of gold, silver or nickel and that is intended to resemble or pass for a current gold, silver or nickel coin;

It should be noted that more than one government department may have a role to play in the requirements and regulations pertaining to the importation of certain goods; it is therefore beneficial to contact any that may play a role.

The Transportation of Dangerous Goods Act, 1992, and its associated Regulations control nine classes of dangerous goods, only seven of which apply to wastes and recyclable materials:

  - Class 2: Gases
  - Class 3: Flammable Liquids
  - Class 4: Flammable Solids; Substances Liable to Spontaneous Combustion; Substances that, on contact with Water, Emit Flammable Gases (Water-Reactive Substances)
  - Class 5: Oxidizing Substances and Organic Peroxides
  - Class 6: Toxic and Infectious Substances
  - Class 8: Corrosives
  - Class 9: Miscellaneous Products, Substances or Organisms

Class 1 (Explosives) and Class 7 (Radioactive) dangerous goods are never wastes by definition under the ElHWHRMR. Information on customs control of explosives and radioactive goods can

be found in Memorandum D19-6-1, Administration of the Explosives Act and Memorandum D19-2-1, Administration of the Nuclear Safety and Control Act

Import Prohibitions and Requirements for Commercial Importers of Aquatic Species and for Travellers Under the Aquatic Invasive Species Regulations

Human drugs, natural health products, medical devices, consumer products, cosmetics, radiation emitting devices, hazardous products and pest control products.

- Controlled Substances and Precursors

(a) **Narcotics** which includes all of the substances in Schedules I and II except for Methylenedioxypyrovalerone (MDPV or "bath salts"), methamphetamine, amphetamines, flunitrazepam and Gamma Hydroxybutyric acid (GHB).

(b) **Controlled drugs** which includes GHB and some of the amphetamines from Schedule I, a portion of Schedule III, all the anabolic steroids and barbiturates under Schedules IV and a portion of the other substances under Schedule IV.

(c) **Restricted drugs** which includes most of the amphetamines from Schedule I and the majority of the substances under Schedule III.

(d) **Benzodiazepines and targeted substances** which includes all of the benzodiazepines and a portion of the other substances from Schedule IV.

(e) **Precursors** are listed under Schedule VI of the CDSA and regulated under the *Precursor Control Regulations* (PCR).

(f) Test Kits/Precursors

(g) First Aid Kits

5 Milk and cream, neither concentrated nor containing added sugar or other sweetening matter, of a fat content, by weight, not exceeding 6 per cent, that are classified under tariff item No. 0401.10.10 or 0401.20.10 in the List of Tariff Provisions set out in the schedule to the *Customs Tariff*.

5.1 Cream, neither concentrated nor containing added sugar or other sweetening matter, of a fat content, by weight, exceeding 6 per cent, that is classified under tariff item No. 0401.40.10 or 0401.50.10 in the List of Tariff Provisions set out in the schedule to the *Customs Tariff*.

6 Milk and cream, containing added sugar or other sweetening matter, in powder, granules or other solid forms, of a fat content, by weight, not exceeding 1.5 per cent, classified under tariff item No. 0402.10.10 in the List of Tariff Provisions set out in the schedule to the *Customs Tariff*.

7 Milk and cream, in powder, granules or other solid forms, of a fat content, by weight, exceeding 1.5 per cent, not containing added sugar or other sweetening matter, classified under tariff item No. 0402.21.11 or 0402.21.21 in the List of Tariff Provisions set out in the schedule to the *Customs Tariff*.

8 Milk and cream, in powder, granules or other solid forms, of a fat content, by weight, exceeding 1.5 per cent, containing added sugar or other sweetening matter, classified under tariff item No. 0402.29.11 or 0402.29.21 in the List of Tariff Provisions set out in the schedule to

the *Customs Tariff*.

9 Preparations (other than preparations classified under tariff item No. 2106.90.31 or 2106.90.32 in the List of Tariff Provisions set out in the schedule to the *Customs Tariff*) containing more than 15 per cent by weight of milk fat, but less than 50 per cent by weight of dairy content, and suitable for use as butter substitutes, not elsewhere specified or included, that are classified under tariff item No. 2106.90.33 in the List of Tariff Provisions set out in the schedule to the *Customs Tariff*.

10 Milk and cream, not in powder, granules or other solid forms, concentrated (whether or not containing added sugar or other sweetening matter) or not concentrated (containing added sugar or other sweetening matter), that are classified under tariff item No. 0402.91.10 or 0402.99.10 in the List of Tariff Provisions set out in the schedule to the *Customs Tariff*.

11 Powdered buttermilk, whether or not containing added sugar or other sweetening matter or flavoured or containing added fruit, nuts or cocoa, that is classified under tariff item No. 0403.90.11 in the List of Tariff Provisions set out in the schedule to the *Customs Tariff*.

12 Buttermilk (other than powdered buttermilk), curdled milk and cream, kephir and other fermented or acidified milk and cream, whether or not concentrated or containing added sugar or other sweetening matter or flavoured or containing added fruit, nuts or cocoa, that are classified under tariff item No. 0403.90.91 in the List of Tariff Provisions set out in the schedule to the *Customs Tariff*.

13 Products consisting of natural milk constituents, whether or not containing added sugar or other sweetening matter, not elsewhere specified or included, that are classified under tariff item No. 0404.90.10 in the List of Tariff Provisions set out in the schedule to the *Customs Tariff*.

13.1 Powdered whey, whether or not containing added sugar or other sweetening matter, that is classified under tariff item No. 0404.10.21 in the List of Tariff Provisions set out in the schedule to the *Customs Tariff*.

13.2 Milk protein substances with a milk protein content of 85% or more by weight, calculated on a dry matter basis, that do not originate in a NAFTA country, an EU country or other CETA beneficiary or Chile, Costa Rica or Israel and that are the subject of two commitments signed by the Government of Canada on June 12, 2008, one with the European Communities and the other with the Government of Switzerland, relating to the modification, in Canada's schedule of concessions pursuant to the Agreement Establishing the World Trade Organization, to Canada's concession on tariff item No. 3504.00.00 in the List of Tariff Provisions set out in the schedule to the *Customs Tariff* with regard to those substances.

14 Mixes and doughs, for the preparation of bread, pastry, cakes, biscuits and other bakers' wares classified under heading No. 19.05 in the List of Tariff Provisions set out in the schedule to the *Customs Tariff*, containing more than 25 per cent by weight of butterfat and not put up for retail sale, that are classified under tariff item No. 1901.20.11 or 1901.20.21 in the List of Tariff Provisions set out in the schedule to the *Customs Tariff*.

15 Milk, cream or butter substitutes containing 50 per cent or more by weight of dairy content,

not elsewhere specified or included, that are classified under tariff item No. 2106.90.31 in the List of Tariff Provisions set out in the schedule to the *Customs Tariff*.

16 Food preparations of goods of heading Nos. 04.01 to 04.04 in the List of Tariff Provisions set out in the schedule to the *Customs Tariff* (other than ice cream mixes or ice milk mixes), containing more than 10 per cent but less than 50 per cent on a dry weight basis of milk solids, not in retail packaging, that are classified under tariff item No. 1901.90.33 in the List of Tariff Provisions set out in the schedule to the *Customs Tariff*.

19 Complete feeds and feed supplements, including concentrates, containing 50 per cent or more by weight, in the dry state, of non-fat milk solids (other than preparations classified under tariff item No. 2309.10.00, 2309.90.10 or 2309.90.20 in the List of Tariff Provisions set out in the schedule to the *Customs Tariff*), not elsewhere specified or included, that are classified under tariff item No. 2309.90.31 in the List of Tariff Provisions set out in the schedule to the *Customs Tariff*.

20 Chocolate ice cream mix and ice milk mix that are classified under tariff item No. 1806.20.21 or 1806.90.11 in the List of Tariff Provisions set out in the schedule to the *Customs Tariff*.

21 Ice cream mixes and ice milk mixes, being food preparations of goods of heading Nos. 04.01 to 04.04 in the List of Tariff Provisions set out in the schedule to the *Customs Tariff*, containing more than 10 per cent but less than 50 per cent on a dry weight basis of milk solids, that are classified under tariff item No. 1901.90.31 in the List of Tariff Provisions set out in the schedule to the *Customs Tariff*.

24 Cheddar cheese and Cheddar types of cheese, grated or powdered, that are classified under tariff item No. 0406.20.11 in the List of Tariff Provisions set out in the schedule to the *Customs Tariff*.

25 Grated or powdered cheese of all kinds, other than Cheddar and Cheddar types, that is classified under tariff item No. 0406.20.91 in the List of Tariff Provisions set out in the schedule to the *Customs Tariff*.

26 Processed cheese, not grated or powdered, that is classified under tariff item No. 0406.30.10 in the List of Tariff Provisions set out in the schedule to the *Customs Tariff*.

27 Blue-veined cheese that is classified under tariff item No. 0406.40.10 in the List of Tariff Provisions set out in the schedule to the *Customs Tariff*.

28 Cheddar cheese and Cheddar types of cheese that are classified under tariff item No. 0406.90.11 in the List of Tariff Provisions set out in the schedule to the *Customs Tariff*.

94 Barley starch that is classified under tariff item No. 1108.19.12 in the List of Tariff Provisions set out in the schedule to the *Customs Tariff*.

95 Malt extract that is classified under tariff item No. 1901.90.12 in the List of Tariff Provisions set out in the schedule to the *Customs Tariff*.

96 Prepared foods obtained by the swelling or roasting of barley that are classified under tariff item No. 1904.10.41 or 1904.10.49 in the List of Tariff Provisions set out in the schedule to the *Customs Tariff*.

96.1 Prepared foods, of barley, obtained from unroasted cereal flakes or from mixtures of unroasted cereal flakes and roasted cereal flakes or swelled cereals, that are classified under tariff item No. 1904.20.41, 1904.20.49 or 1904.20.64 in the List of Tariff Provisions set out in the schedule to the *Customs Tariff*.

97 Barley cereals, in grain form or in the form of flakes or other worked grains (except flour and meal), pre-cooked or otherwise prepared, not elsewhere specified or included, that are classified under tariff item No. 1904.90.40 or 1904.90.64 in the List of Tariff Provisions set out in the schedule to the *Customs Tariff*.

98 Barley bran, sharps and other residues, whether or not in the form of pellets, derived from the sifting, milling or other working of barley, that are classified under tariff item No. 2302.40.12 in the List of Tariff Provisions set out in the schedule to the *Customs Tariff*.

Cut Roses and Rose Buds

99 (1) In this item, *imported from israel or another CIFTA beneficiary* has the meaning assigned by the *Regulations Defining Certain Expressions for the Purposes of the Customs Tariff*.

(2) Cut roses and rose buds, fresh, suitable for bouquets or for ornamental purposes, that are imported from Israel or another CIFTA beneficiary and that are classified under tariff item No. 0603.10.11 or under heading No. 98.04 or 98.26 in the List of Tariff Provisions set out in the schedule to the *Customs Tariff*.

means any vehicle (assembled or disassembled) that, when in its assembled state, is capable of being driven or drawn on roads by any means other than muscular power exclusively, but does not include any vehicle designed to run exclusively on rails. The prescribed (or regulated) classes of vehicles under the MVSr are:

- passenger car (including limousines)
- multi-purpose passenger vehicle (including vans, minivans, SUVs, motorhomes, 4x4s)

- truck (including chassis cabs and service trucks)
- bus (including school buses)
- low speed vehicle
- open and enclosed motorcycle, motor tricycle, and limited speed motorcycles (scooters)
- restricted-use motorcycle (RUM) (including ATV and dirt bike)
- trailer, all kinds (including utility, cargo, with mounted equipment, horse, boat, travel trailer, car dolly, etc.)
- trailer converter dolly
- snowmobile and snowmobile cutter
- three wheeled vehicles

used vehicle

means a vehicle that is (or was previously) registered and licensed for which a title or ownership document is (or was once) issued.

- Importation of Tires
- Importing and Exporting Firearms, Weapons and Devices
- Transportation of Dangerous Goods
- Cross-border Currency and Monetary Instruments Reporting
