

DHL Global Forwarding GmbH, Germany - Side Charges Ocean Freight, Febuary 2025

Demurrage, Detention und Quay Storage

The following conditions are valid for import and export shipments under Danmar Lines Bill of Lading respectively ocean freight shipments booked by DHL Global Forwarding GmbH,

Germany, via the ports of Hamburg, Bremerhaven, Wilhelmshaven, Rotterdam, Antwerp and Zeebrugge.

Demurrage-Billing as well as the billing of Quay Storage will be effected per beginning calendar day including weekends and public holidays starting with the day of delivery to the export terminal respectively with the day of vessel arrival at the destination terminal. Freetimes and conditions for containers containing hazardous goods, Reefer-Containers or Special Equipment Containers will be charged individually. Detention billing will be effected from the day of pick up empty/full until the day returned to CY/inland depot.

Storage and days free of charge in inland depots deviate from below mentioned tariff and are available upon request - the arrival day at the depot plus another calendar day would be free of charge here.
