## EXTENSIVE

No matter who is responsible for it: legal liability often covers a damage only partly. Some transport insurances offer insufficient protection. Therefore insure your shipments with DHL Cargo Insurance. As a result, you receive worldwide insurance cover for values of goods of up to 5 million euros, regardless of the mode of transport used. This also applies in cases where there is no legal liability, for example natural disasters, theft, accidents caused by third parties or other unavoidable events due to force majeure.

## CLEAR

The few insurance exclusions – for example in the case of inadequate packaging – are clearly defined at DHL Cargo Insurance, so there are no unpleasant surprises in case of damaged goods.

## EASY

Security instead of bureaucracy: With a one-off agreement, you receive insurance cover for all goods that you ship with DHL Freight. On the basis of the agreed conditions and documented values of goods, we calculate the insurance premium for each of your shipments and invoice it simultaneously with the costs for freight.

Damage immediately upon loading and unloading	Usually no liability (§ 412 HGB)	Full compensation
Exceeded delivery time which leads to pure financial loss	3 x the value of the freight (§ 431 HGB) Single value of the freight (Art. 23 CMR)	On request before placing the order
