- DDP shipments are subject to storage and governmental charges.
- Accepted rates are valid until further notice and subject to change based on airline rate changes and space availability.
- Surcharges are subject to change and vary per carrier.
- Above rates are only valid for normal, stackable and non dangerous goods with a maximum height of 160 centimeters.
- Dangerous goods & battery shipments are always subject to carrier approval; additional charges might apply.
- Rates will be charged per kilogram based on the chargeable weight, unless otherwise specified.

## General Conditions

- Above mentioned rates are excluding VAT, duties and advance payment fee (3% over VAT and duties).
- For shipments within the European Union above rates are excluding 21% VAT.
- Payment terms: in case no credit has been granted to your company, payment by means of wire transfer. In case credit has been granted to your company, payment must occur within 14 days after the invoice date.
