LCL "Origin & Destination charges" will be charged based on chargeable weight, which is the greater of gross or volumetric weight. For LCL cargo volumetric weight is determined using a factor of 1:3, meaning, for instance, a volume of 1 cubic meter has an equivalent volumetric weight of 300 kilograms (referred to in the quotation as "density ratio").

All LCL charges can be subject to a minimum shipment size. The minimum is 1 cubic meter, unless explicitly specified otherwise.

- 2. Truck Waiting Time (after 6 hours free time): PHP 800.00/hour/tractor head.
- 3. Bobtail (if applicable): 100% of the trucking rate for trips outside of Metro Manila. Pull-out of empty van shall be within 48hours from pull-out advice exclusive of Sunday/holidays.
- 4. Foul Trip: 100% of the trucking rate.
- 5. Container Detention: as per receipt for the account of the client.
- 6. TABS charge: Import Loaded as per available zone. Return of Empty at ATI/MICT (if applicable) as per available zone. Screenshot of the booked zone with fee will be provided.
- 7. CY fee shall be billed as per receipt.
- 8. Overweight Fee (Capacity: 20ftr 18Tons; 40ftr 21Tons): PHP 2,000.00/cntr
- 9. Return of Empty Van to CY/depot shall be within 24 hours after gate out (exclusive of Sundays/holidays).
- 10. 10% Fuel surcharge on the trucking rate for every PHP 3.00 increase from the base Fuel Pump Price of PHP 42.00/liter.
- 11. Standard 1 Driver and 1 Helper
- 12. Shipper/consignee is responsible for loading and unloading.
- 13. Insurance is for the account of the customer.

EMPTY RETURN DIVERSION:

POD BTG - 75% trucking rate if diverted to a CY outside Batangas

POD Subic - 75% trucking rate if diverted to a CY outside Subic

POD Manila -75% trucking rate if diverted outside Metro Manila & 100% trucking rate if diverted to Bulacan or Batangas

Loaded diversion will be computed on a prorated basis, depending on the location of diversion

Liability of damage or loss is subject to limits of DHL Global Forwarding's General Trading Conditions as specified in the HAWB or HBL
